



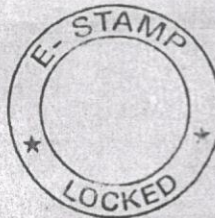
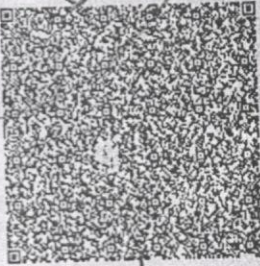

POWERS FUNCTIONS RIGHTS AND DUTIES OF THE TRUSTEES OF THE SAID TRUST

1. The Number of trustee shall be not less then two or not more then nine.

2. Without effecting the generality of powers and duties and functions of the trustees to manage and administer the trust. The Board of trustees shall have the following functions:-

i) To borrow if needed by against the security or the assets of the trust by way or bank over drafts loan or otherwise as may be necessary for the benefits of the trusts provided however the trustees unanimously agreed on such borrowing and limits to the terms of this decisions or agreement and or authorize two or more of the trustees to executes such documents, deed papers etc and as may be necessary in connection the trust.

ii) To arrange for, authorizing the signing authority, or executions of any agreement contract installments, documents or any other paper in writing requires to be signed or executed on behalf of the trustees by any two or the trustees to be nominated in this behalf by the board of trustees & with the consent of the settler and to make the same effective and binding as if the agreement of contracts instruments or document or paper or writing were signed were signed by all the trustees.

ii) To appoint or make provisions for the appointments of a committee and trustees and or others to attend or to supervise or conduct specified jobs or functions of the trust matter in such manner and subject to such rules and regulation as The Trustees may prescribed.

iv) To authorize any one or more trustees to hold any property or any fund or any investment of the trust subject however to the terms of these presents in such manner and subject to such terms and conditions rules and regulations the

v) To spend any portion of the corpus funds or the income of the trust for purchasing any land or construction or building for the trust.

vi) Awarding scholarships and fellowship and grants by way of loan and otherwise and on such terms and conditions as the trustees may think fit for the purpose to undertaking prosecution and encouraging in India or in any foreign country research or other work in any branch of any arts subjects Engineering Technology Electric Therapy Radiology and Bacteriology Medicinal science or branch or part subject or modern applied science in their widest and most comprehensive sense.

3. Trustees shall have full powers to organize the programmes of the trust by organizing suggesting or by adopting or rejecting the proposals from the public and may delegate any of the powers of professionals or administrative, staff whose reports of and activities shall be arranged to be received periodically to control and to give guidance in this regards thereto.

4. In additions to all the powers hereby conferred on them and without detracting from the generality of their powers board of trustees shall have the following powers.

a) To expend the fund of the trust in such manner as they shall consider most beneficial for the purpose of the trust and subject to the provisions thereof as they may deem fit and to expend the sale proceeds of any such sale for the purpose of the trust.

b) To acquire in the name of the trust or the board of trustees build upon pull down re-build add to alter repair improve sell to let-out on rent exchange or dispose off or otherwise deal with any lands buildings or premises for the purpose of the trust.

- d) To enter into contracts on behalf of the trust and to secure the fulfillment of any such contracts or arrangements.
- e) To borrow money upon the security of any of the property of the trust and to grant or direct to be granted mortgages for securing the same.
- f) To make and from time to time to repeal or alter regulations as to the management of the trust and the affairs thereof and as to the duties of the honorary or salaried secretary officers or servants of the trust and as to conduct of business by the committee of management or any sub-committee or as to any of the matters or things within the powers or under the control of the committee of management provided that the same shall not be inconsistent with the objects of the trust.
- g) To insure and keep insured the trust properties and other charges and outgoings payable in respect thereof.
- h) To use and take lawful ways and means for recover of any monies due to the trust or for realization of any security or other property movable or immovable belonging to the trust and to settle adjust compound submit to arbitration compromise withdraw actions accounts claims demand whatsoever, whether arising from any legal proceedings or not.
- i) To employ any staff as may be necessary for the administrator and management of the trust properties and of the institutions established pursuant to these presents and to pay their salaries and at their discretion to remove such staff to pay audit fees and incurred all other necessary charges and expenses for

j) To sign, endorse, and negotiate Cheques Bills of exchange, drafts debentures, debenture stock, G.P Notes and other Government /Semi Government local or public loans papers and instruments and to ask demand draw realize collect compound sign endorse and to negotiate all interests dividends warrants bonuses and other benefits to accrue in respect of the trust properties and the investment thereof.

k) To purchase the machinery tools of farmer and agricultural equipment.

l) To organize plantation programme.

5. The trustee shall have powers from time to time to make and alter or amend the rules and regulations of needed, with the consent of the settler so made this regards of which any power or duty is vested in them as they may think fit and proper.

6. The trustee may appoint advocate, secretaries, Engineers surveyors or other employees for the purposes of management and supervisions of the trust estate funds for collection of rents effects and profits for keeping the account and record and for other purposes of the trustees.

7. The trustee have full power to compromise or compound an suit and other proceedings and settle differences, and disputes touching the trust estate and/or the trust properties and to refer any such differences, disputes to arbitration and to adjust and settle all accounts relating to the trust estate and/or the trust properties and to do all other acts and things fully and effectually without being liable or answerable for any bonafide losses occasioned thereby.

8. The decisions of majority of the members shall prevail and in the event of the tie the founder/settler of the meeting shall have the power of casting of his votes.

9. Any resolution passed by the 2/3rd majority of the present trustees with the consent of the settler for the benefits and the same shall be prevail and applicable to the members.

10. A person shall cease to be trustee in case if he/she dies or if becomes bankrupt or become in same or otherwise incapable to act or if any trustee or trustees/resigns from his/her or removed by the board of trustees with the consent of the said settler by 2/3rd majority shall be removed from his office.

11. A Trustee shall be at liberty to retire from the trust voluntarily and he or she shall be disqualified to hold his/her office and he becomes or is declared bankrupt or insolvent or a lunatic or becomes of unsound mind though not so found on inquisition or leaves the Indian Union. However voluntary retirement will be valid from the date it is accepted by board of trustees.

12. No trustee shall be liable for any loss not attributable:

(a) To her or his dishonesty.

(b) To willful commission by her or his of any act known by her or him to be a breach of trust.

And in particular he or she shall not be bound to take any proceedings against a co-trustees for any breach or alleged breach of trust committed by such trustees nor shall he be accountable for any loss occasioned by or for the default of his co-trustee nor value not received or realized by his/her or him although he may have signed the receipt therefore jointly with the other trustee or trustees for the sake of conformity or otherwise.

13. If any one or more of the objects specified herein, appear not to be objects of a public charitable nature the trustees shall not carry out such objects or object at the gain achieved, the trust shall not be effected in any manner.

14. The Board of trustees/managing trustee shall keep proper books of accounts with respect to all sums of monies received and expended by the trust and of the matters in respect of which receipts and expenditure relate to, and of the properties for the time being vested in them and of all liabilities in connection therewith.

15. A balance sheet and income & expenditure account of the trust shall be audited once every year by a recognized firm of auditors to be appointed by the trustees and laid before the board of trustees made up to a date not more than twelve months before such meeting.

16. The auditors shall audit yearly accounts of the trust and shall prepare and lay before the board of trustees every year thereafter as may be possible but before the annual meeting an annual statement of the receipts and expenditure of the trust upto the last day of March, immediately preceding for submission to the annual meeting.

NO PERSON OF THE BOARD OF TRUSTEE SHALL BE :-

- I) An undischarged insolvent or.
- II) Convicted of an offence involving moral turpitude or heinous crime.
- III) Of unsound mind or.
- IV) A minor





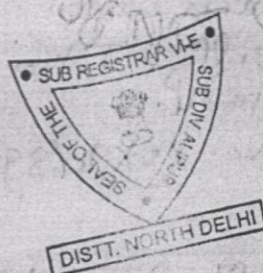
